Subject: - Regarding adjustment of displaced extension lecturers.

A number of displaced extension lecturers have approached this office for their adjustment against workload in one or other college. It is clear that these were to be adjusted by the Principal concerned in view of instructions dated 20.9.2017, 15.01.2018 & 13.7.2018 issued regarding adjustment of extension lecturers.

A list of such persons is attached herewith for their adjustment as per procedure given below:-

- These extension lecturers will approach college of their choice via email within two days. Other displaced eligible extension lecturers can also apply whose names are not in this list.
- 2. At first, those eligible extension lecturers will be adjusted in same college from where he/she was relieved earlier, if workload is available.
- 3. Thereafter, in case of availability of further unmet workload, the other eligible extension lecturers, displaced from other Govt. colleges will be considered whose seniority will be determined on the basis of length of service {to be decided on the basis of experience certificates issued by Principal(s)}. The incumbent having longest experience will be adjusted. In case of his/her refusal or non-joining within one day, the next person can be given chance to be got adjusted. In case of same length of experience, the senior in age will be considered. The credentials (e.g. eligibility, conduct, result etc.) of adjusted extension lecturer will be verified by the Principal concerned from previous college. This verification will be done at the time of scrutiny of applications as well as before finally adjusting the eligible extension lecturers.

4. It is further clarified that in future, other applicants be adjusted at their own level keeping in view of provision policy dated 20.7.2017 and 13.7.2018.

In addition to this, MIS database may also be updated after adjustment drive.

It is informed that in the selection process for various posts of Extension Lecturers in different subjects including the subject of Environment Studies, the petitioner was duly selected on her merit by a duly constituted selection committee by the Principal, Government College for Women Ratia. However, the petitioner did not allow to serve there due to non availability of work load.

Therefore, the petitioner submitted application in the office of Director, Department of Higher Education Panchkula on 07.08.2018 requesting that she may kindly be allowed to join in one of the Govt Colleges as the state is in process of adjusting those Extension Lecturers who have been selected or rendered their services in some of the Govt Colleges in the State. The candidature of petitioner was selected by the Director, Department of Higher Education Panchkula and name of the petitioner is at Sr No. 94 of the selected list of extension lecturer for adjustment dated 30.08.2018.

In view of aforesaid selection, the petitioner has joined in the CMG GCW Bhodia Khera, Fatehabad on 07.09.2018 as sufficient workload is available in this college.
